# **Overview**

He successfully tried to conclusion an unfair labor practice case involving the alleged discriminatory discharge of four nurses from a Florida hospital. He successfully defended a wage-hour class action in Florida federal court.

Anthony previously served as co-chair of the firm's Healthcare Industry Group and previously was a member of Littler's Board of Directors. Additionally, he has published and lectured extensively for a variety of legal, business and human resource organizations.
